### 1. Personal data collected

In line with the purposes described in the present Privacy Policy, we use personal data under the following categories:

- Identification data.
- Contact information.
- Labour data
- Financial and estate information.
- Tax information.
- Other data, as long as they are strictly necessary to provide the legal services required.

### 2. Purposes of the data treatment

Personal data collected or obtained by DLG is used for the following purposes:

- Create a database to maintain contact with clients.

### 3. Personal data transmission

#### **4. Procedures to give effect to your rights regarding personal data and to revoke your authorization for their treatment**

Regarding the procedure and requirements we inform you the following:

a) What information and/or documentation must the request contain?

- Identification data, specifying name, email address and phone number, attaching the proper documents to verify your identity, and a description of your request.

b) By which means can the owner of the personal data or his/her authorized representative can demonstrate their identity?

- The owner of the personal data can demonstrate his/her identity with a passport, elector's credential, professional certification card. His/her representative must present one of the above mentioned documents and a legal document that provides such representation; for minors and persons that by law require representation, the requirements must be fulfilled in accordance to the Federal Civil Code.

c) How many days will it take to obtain a response?

- 10 working days from the date the request has been received.

d) How will the response be communicated?

- By email.

e) How will the personal data requested be reproduced?

- In electronic or physical means.
